RE: Boulder County's Moratorium on Oil and Gas Development

Dear Honorable Commissioners:

For the past five years, since February 2, 2012, Boulder County has prohibited new oil and gas development within its borders. It has done so through multiple and continuous "temporary" moratoriums. The latest, which was announced on December 13, 2016, extends through at least May 1, 2017. But, consistent with past practice, there is reason to suspect that the County will continue its pattern of extending its "temporary" prohibition beyond even that date.

The County's continuous five-year ban on oil and gas development violates state law. In two decisions issued just last year, the Colorado Supreme Court made clear that local governments may not prohibit oil and gas development at the local level. *City of Fort Collins v. Colo. Oil & Gas Ass'n*, 369 P.3d 586 (Colo. 2016); *City of Longmont v. Colo. Oil & Gas Ass'n*, 369 P.3d 573 (Colo. 2016). Neither permanent nor temporary bans are allowed. In *City of Fort Collins*, the Court struck down a five-year moratorium, explaining that the temporary ban undermined the State's interest in the efficient and responsible development of oil and gas resources and "deleteriously affect[ed] what is intended to be a state-wide program of [oil and gas] regulation." Boulder County's ban on oil and gas development from February 2012 through May 2017, and perhaps longer, exceeds the five-year moratorium the Colorado Supreme Court struck down in *City of Fort Collins*. The County's ban is clearly unlawful.

If Boulder County does not rescind its ban on oil and gas development by February 10, 2017, or if the County takes other steps to impede the efficient and responsible

development of oil and gas resources, my office will take appropriate legal action consistent with the recent opinions of the Colorado Supreme Court.
